Camp Verdugo Oaks has a volunteer Campmaster Corps that on occasion can provide supervision for the Air Gun and Archery ranges. However, it is understood that Verdugo Hills Council Boy Scouts of America, is NOT responsible for any program or direct supervision of any facilities or swimming pool while your group is at camp. Your group must comply with the rules and regulations that govern all users while at Camp Verdugo Oaks. These rules and regulations include the following:

## Air Gun Range:

Each group must provide a certified, trained air gun range master who will be in direct supervision at all times the range is open in the event there is not a qualified Verdugo Oaks Campmaster available.

## Swimming Pool:

All Groups using Camp Verdugo Oaks Swimming pool must have a certified Lifeguard.  
Qualifications: 21 years of age, Red Cross, County, YMCA and BSA Aquatics Director.

**Certified individuals must have their certifications with them at camp and be physically capable of performing the lifesaving functions.**
