Fees: Please write out a separate check for the \$400.00 deposit so it may be returned to you. Deposits will be refunded 1 week after canoes are returned. Each canoe contains 2 life jackets, 3 paddles and 1 tie-off rope (painter). You will get 2 sets of keys and a copy of the Trailer Registration. Canoes are kept at Camp Verdugo Oaks in Castaic, and must be picked up and returned to camp. Rental package includes 8 canoes.

Liability Clause: The adult leader signing this form accepts all responsibility for the condition of the canoes, trailer, life-jackets, paddles, locks & keys from the time of issuance to the date when the deposit has been returned. All damages over and above the \$400 deposit will be assessed at the current replacement value. The canoe trailer **MUST** be locked at all times. A lock/key is provided.

Cancellations: If reservations are cancelled 30 days prior or more to the reservation date, no penalties will be assessed and you will be given a full refund. If reservations are cancelled less than 30 days prior to the reservation date, your reservation deposit will be forfeited.
